California Community Colleges: Student Success Act of 2012

FACT SHEET

PURPOSE

To provide critical support services to students on the front-end of their educational experience to increase student success.

SUMMARY

1. Establishes the Student Success Act of 2012;
2. Requires a college or district receiving matriculation funds to provide student support services including orientation, assessment and placement, counseling and other education planning services, and academic interventions for students to ensure academic success to achieve their educational goals;
3. Requires the college or district to evaluate the effectiveness of the Student Success and Support Program and other programs to facilitate student success, including disaggregated data by ethnicity, age, gender, disability, and socioeconomic status;
4. Requires students to identify an educational goal such as degree, career technical certificates, transfer preparation, or career advancement, and to declare a specific course of study after a specified time period or unit accumulation;
5. Requires students qualifying for a BOG fee waiver to meet academic progress standards;
6. Requires the Board of Governors, in consultation with students, faculty, and other key stakeholders, to develop, adopt, and phase in policies over a reasonable period of time and as resources are available.
7. Requires the LAO to review and report to the Legislature by July 1, 2014.

BACKGROUND

The California Community College system is an accessible and affordable gateway to educational advancement for the 2.6 million students it serves. However, budget reductions over the years have led to many first-time students being turned away, existing students not getting the classes they need, and student support services, such as counseling, assessment and orientation to be drastically cut. The result has been too many students not getting the guidance and courses they need to reach their goals of a degree, certificate, transfer or career advancement.

Senate Bill 1143 (Liu) of 2010 directed the California Community Colleges to establish a task force and develop a plan to promote and improve student success by the beginning of 2012. The 20-member Student Success Task Force composed of community college CEOs, faculty, students, researchers, staff and external stakeholders, spent a full year researching, studying and debating the best methods to improve student outcomes. Their plan resulted in 22 specific recommendations which identify key strategies to invest in student success and enable students to reach

their goals. These recommendations will be implemented through Title 5 regulations, system-wide administrative policies, local best practices, and legislation.
